- IF YOUR COMPANY IS REGISTERED IN FRANCE, IT IS MANDATORY to mention your company is VAT No. & EORI No. on all documents & fill our Customs representation power of attorney.
YET IF NOT REGISTERED IN FRANCE, CLEARANCE WILL STILL BE COMPLETED BY MATHEZ ONSITE.
- INTEGRATORS/COURIERS like UPS, DHL or FEDEX CAN NO LONGER COMPLETE DDP Deliveries to France without a French VAT & EORI No. DDP will most likely be handled like a DAP by couriers and shipment will then be delayed.
- If THESE COURIERS ever use MATHEZ'S VAT No. to clear your shipment without our agreement, VAT, couriers fees & cash advance charge will be passed on to your company – these may be subject to a separate invoice at a later date & cannot be contestable.
